- **Conflict of Interest:** Disclose any potential conflicts of interest, especially if serving as a board member or family member of a board member.

7. Termination of Agreement

This agreement may be terminated at any time by either CNSF or the volunteer with reasonable notice. CNSF reserves the right to end the agreement if the volunteer does not meet the organization's standards of conduct, fails to fulfill their role, or violates any terms of this agreement.

8. Waiver of Liability

The volunteer acknowledges and agrees to release CNSF from any liability for injuries, damages, or losses that may occur during the volunteer's service, except in cases of gross negligence or willful misconduct on the part of CNSF.
